Tuition Payment

Monthly Tuition Payment Plan: The German International School of Houston offers monthly tuition payments.

Enrollment by June 15, 2025:

Total Enrollment Fees + 1 month of Tuition (incl. Extended Day Program, if applicable) at enrollment + 9 monthly tuition payments starting on July 15, 2025 + Summer Enrollment Total (if applicable) on April 15, 2026.

Enrollment by February 15, 2025: Offers reduced Administration Fee.

Enrollment after June 15, 2025 and during the 2025-2026 school year:

Total Enrollment Fees + 2 months of Tuition (incl. Extended Day Program, if applicable) at enrollment + monthly tuition payments starting on the 15th of the month following the enrollment + Summer Enrollment Total (if applicable) on April 15, 2026.

Enrollment is for the entire 2025-2026 school year, as outlined in our 2025-2026 Academic Calendar, + 2026 Summer Enrollment (if applicable).

Policies

Enrollment Application:

Parents submit a completed GAES dba German International School of Houston Enrollment Contract together with the payment corresponding to their choice of program. Early enrollment guarantees a placement for your child in the applicable classroom.

Re-Enrollment:

Re-Enrollment starts once the new enrollment contract for the school year is published. Returning students and siblings are given priority enrollment.

Siblings:

Siblings are given priority enrollment on a first come, first served basis after currently enrolled students are placed. Sibling status does not guarantee an opening. The Administration Fee for 2nd+ sibling is waived. Waiting list placement for siblings is recommended!

Waiting List Students are given priority enrollment on a first come, first served basis after currently enrolled students and siblings are placed. The paid Waiting List Placement Fee is credited towards the Administration Fee at enrollment.

Open Enrollment:

Remaining openings are distributed on a first come, first served basis after the end of the priority enrollment period.

Enrollment Confirmation:

A child is enrolled/re-enrolled after the written confirmation by the School that an opening is available for the child. The Enrollment Contract, together with the Parent Handbook, as amended from time to time, constitutes the entire agreement between the family and GAES dba German International School of Houston, superseding any prior agreement. The entire agreement is equally valid for enrollment in the Additional Summer Months.

Refund Policy:

All paid tuition and fees are non-refundable. Refunds or allowances in tuition cannot be made for absences in the event of illness, vacations and extended personal leaves, at the occasion of holidays, unexpected school closings or other circumstances.

Tuition may be refundable for school-initiated dismissal of a student or family while in attendance. The Board of Directors will decide upon each case after gathering information from teachers and parents. The Board of Directors holds the right to not issue any refunds.

- Withdrawal: All withdrawals are to be submitted in writing to office@gish-houston.org.
- Payment Policy: Tuition payments are due on the 15th of the month.
 - A 10% late fee will apply after the 25th of the month and will be enforced.
 - For all tuition payments, GAES dba German International School of Houston accepts either payments via Zelle, pre-dated checks or automatic bank payments you initiate via bill pay and your bank will send the check to us on your behalf.
 - The pre-dated checks (made out to GAES dba German International School of Houston) or the set-up confirmation for automatic bank payments are to be submitted to the office by June 15, 2025, or for later enrollment on the 1st day of attendance. A \$25.00 penalty per month will be applied to your account until the pre-dated checks or the set-up confirmation for Automatic Bank Payments are submitted.
 - Automatic bank payments are to be set on the 5th of each month to arrive on time.
 - Additional Fees: A charge of \$50.00 will be assessed for each returned check.

- ▶ I/We am aware that a copy of the *Texas Department of Human Services "Minimum Standards"* is available in the office of the *German International School of Houston* for parents who wish to review them.
- ▶ I/We understand that the Parent Handbook, as amended from time to time, as well as any addendum, are part of the Enrollment Agreement. The latest edition of the Parent Handbook, as well as possible addendi, are available for review in the office of the *German International School of Houston* and on the school website. At enrollment, parents receive a copy via e-mail.
- ▶ I/We am aware that the laws of the State of Texas require students to have specific records on file (immunization, physical, vision and hearing screening, etc.), and accept to submit the required forms before the first day of attendance and keep them updated throughout the school year.
- ▶ I/We understand that the obligation to pay tuition and fees is unconditional, and that all paid tuition and fees are non-refundable. Furthermore, I understand that it is important to make payments in a timely manner, and that additional fees may apply for additional curriculum-related activities.
- ▶ I/We am aware that enrollment in the 3-day program does not guarantee the participation in all curricular activities.
- ▶ I/We understand that for K-class + higher grades tardy passes, progress + report cards are issued + 10 unexcused absent days apply.
- ▶ I/We understand my duty as a parent to be actively involved in school activities and school events. Parents choosing the Family Tuition commit to 10 Volunteer Hours per enrolled child per school year and sign the GISH Volunteer Agreement.
- ▶ I/We am aware that pictures of my child are taken during the school day and school related events. I authorize the use of my child's photograph and information in school publications or related websites without compensation. Any variation is to be submitted in writing.
- ▶ I/We understand that, as a parent, I am liable for any loss or damage to school or church property caused by my child.
- ▶ I/We understand that the Director of the *German International School of Houston*, with the approval of the Board of Directors, has the right to suspend or terminate any enrollment contract.
- ▶ I/We agree to abide by the policies and procedures stated above. The **GAES dba** *German International School of Houston* reserves the right to modify policies and procedures during the school year. Parents will receive written notice prior to the initiation of change.
